I/We acknowledge and agree that SDG Securities (HK) Limited ("SDGS") may collect, store, process, use, disclose and transfer personal data relating to me/us (including my/our CID¹ and BCAN(s)²) as required for SDGS to provide services to me/us in relation to securities listed or traded on The Stock Exchange of Hong Kong Limited ("SEHK") and for complying with the rules and requirements of the SEHK and the Securities and Futures Commission ("SFC") in effect from time to time.
